2nd Minutes of Meeting of Technical Evaluation Committee (TEC) to open and evaluate technical bid for "Construction of 2 laning with hard shoulder configuration of Chhumkhum of Tlabung from design Chainage Km 37.420 to Km 74.950 (Pkg-B) for Lunglei-Tlabung section of NH-302 in the state of Mizoram under 'Bharatmala Pariyojana' on EPC mode".

Date: 26.03.2021 (05.40 PM)

Venue: NHIDCL HQ, New Delhi

Member Secretary apprised the Technical Evaluation Committee (TEC) that Technical Evaluation of responsive bids as per clause 3.1.6.1 of RFP was carried out by the TEC in its 1st meeting on 25.03.2021 at 05.10 PM (Minutes of Meeting is attached). The result of Technical evaluation was published on 25.03.2021 and the financial bids are scheduled to be opened on 27.03.2021 at 11:15 AM.

2. One representation has been received from M/s. Ram Kumar Contractor vide letter dated 25.03.2021 (copy enclosed) mentioning that the bidder has sufficient experience for similar work and submitted the Experience certificate issued by the client. Earlier, the bidder has only attached the Experience certificate issued by the Authority's Engineer in the bid. Accordingly, the Committee examined the certificate submitted by the bidder w.r.t. already claimed project under the eligible projects and recommended that the Experience certificate may be considered for the similar work claimed by the bidder in its bid.

3. Another representation has been received from M/s. Power Mech - Bekem (JV) vide letter dated 26.03.2021 (copy enclosed). The bidder requested to consider the work at project code '2a' executed by its JV member M/s. Bekem Infra Projects Pvt. Ltd. as a Sub-Contract from M/s. SEW Infrastructure Ltd. in accordance with clause 2.2.2.5 (iii) and 2.2.2.6 (ii) of RFP as amended vide Amendment No. 2 for the similar work for the subject project. TEC noted that the client has not recognized M/s. Bekem Infra Projects Pvt. Ltd. as Sub-Contractor and no client certificate has been submitted by the bidder which is required as per clause 16 of Annex-IV of Appendix-IA. Accordingly, TEC recommended that there will be no change in the earlier evaluation.

4. Also, one bidder namely M/s. CDS Infra Projects Ltd. was declared by the TEC as 'Non responsive' due to 99% share is held by the person outside India and as per clause 2.1.12 of RFP, "The bidding is open to persons from India only". However, the bidder has submitted a representation vide letter dated 26.03.2021 (copy enclosed) and clarified the following:

- a) The Company was incorporated in the year 2004 as wholly owned subsidiary of a foreign Company "OJSC Centrodorstroy Moscow". Thereafter in the year 2009, an Indian

Company "O.P. Gupta & Sons Pvt. Ltd." took over the major shareholding (95.3%) of CDS Infra Projects Limited. Further in the year 2013, foreign directors and foreign Company completely exited the Company, CDS Infra Projects Limited.

- b) As on date, the Company, CDS Infra Projects Ltd, is purely an Indian Company. It has no foreign directors and no foreign shareholders. All the Directors and Shareholders of the Company are of Indian Nationality and the Company is subsidiary of an Indian Company "O.P. Gupta & Sons Pvt. Ltd."
- c) In regards to details mentioned in Memorandum and Articles of Association of the Company DCS Infra Projects Limited, please note that these details of first subscribers/shareholders and first directors of the company were mentioned in MOA & AOA at the time of incorporation of the Company and it will remain mentioned here in MOA & AOA throughout the existence of the Company. After incorporation, any changes made in the Company such as shareholders and directors etc. during the existence of the company, these changes are separately filed with Registrar of Companies at Ministry of Corporate Affairs (MCA) as and when changes are made.

Please note that as on date the Status of the Company, CDS Infra Projects Limited, may also be verified with Registrar of Companies at Ministry of Corporate Affairs (MCA) that CDS Infra Projects Limited is purely an Indian Company with Indian Directors and Indian Shareholders. List of Directors and Shareholders of the Company alongwith Company Master Date available with Registrar of Companies has also been submitted by the bidder.

Considering above, TEC recommended that the bid of the above mentioned bidder may be considered for technical evaluation. TEC further examined the responsiveness of bidder in accordance with clause 3.1.6.1 of RFP and found responsive.

5. Considering above, TEC discussed and deliberated on the Technical bids of above mentioned two bidders and noted the following w.r.t. the eligibility criteria for technical qualification:
