2nd Minutes of Meeting of Technical Evaluation Committee (TEC) to open and evaluate technical bid for "Construction of 2 laning with hard shoulder configuration of Lunglei to Chhumkhum from Design Chainage 0.000 to km 37.420 (Pkg-A) for Lunglei-Tlabung section of NH-302 in the State of Mizoram under 'Bharatmala Pariyojana' on EPC mode".

Date: 26.03.2021 (05.50 PM)

Venue: NHIDCL HQ, New Delhi

Member Secretary apprised the Technical Evaluation Committee (TEC) that Technical Evaluation of responsive bids as per clause 3.1.6.1 of RFP was carried out by the TEC in its 1st meeting on 25.03.2021 at 05.00 PM (Minutes of Meeting is attached). The result of Technical evaluation was published on 25.03.2021 and the financial bids are scheduled to be opened on 27.03.2021 at 11:00 AM.

2. One representation has been received from M/s. Ram Kumar Contractor vide letter dated 25.03.2021 (copy enclosed) mentioning that the bidder has sufficient experience for similar work and submitted the Experience certificate issued by the client. Earlier, the bidder has only attached the Experience certificate issued by the Authority's Engineer in the bid. Accordingly, the Committee examined the certificate submitted by the bidder w.r.t. already claimed project under the eligible projects and recommended that the Experience certificate may be considered for the similar work claimed by the bidder in its bid.

3. Second representation has been received from M/s. Power Mech - Bekem (JV) vide letter dated 26.03.2021 (copy enclosed). The bidder requested to consider the work at project code '2b' executed by its JV member M/s. Bekem Infra Projects Pvt. Ltd. as a JV member (24.50% share) in BSCPL - Bekem - RE (JV) for the similar work for the subject project. TEC noted that as per the client certificate, though the project has been 93.03% completed and as per the 24.50% share of M/s. Bekem Infra Projects Pvt. Ltd., executed value comes Rs. 79.07 Crore but the this project at project code '2b' i.e. "Construction of important bridge across river growthami with RCC column sub-structure on double D well foundations and execution of protective and miscellaneous works (excluding execution of super structure as 44x76.20 m clear span with steel through girders)" can not be considered as Similar work because the bidder has only executed the Bridge upto sub-structure level as per the scope of work. Accordingly, TEC recommended that there will be no change in the earlier evaluation.

4. Third representation has been received from M/s. Engineering Projects (India) Ltd. vide letter dated 26.03.2021 (copy enclosed). The bidder requested to consider the work at project code 'b' as Similar work. TEC noted that as per the supporting documents submitted for the project code 'b' in the bid, the bidder has entered into an MOU with PWD, Uttarakhand for construction of 4 separate works (Flyovers) and the bidder has submitted completion certificate by clubbing the completed works of 2

Flyovers out of 4 works into one completion certificate and the construction cost of each works (Flyover) is Rs. 40.42 Cr and Rs. 39.26 Cr which is below than the required criteria for Similar work i.e. Rs. 75.86 Crore. Accordingly, TEC recommended that there will be no change in the earlier evaluation.

5. Considering above, TEC discussed and deliberated on the Technical bids of above mentioned two bidders and noted the following w.r.t. the eligibility criteria for technical qualification:
