2nd Minutes of Meeting of Technical Evaluation Committee (TEC) to open and evaluate technical bid for “Rehabilitation and Up-gradation to 2 lane with paved shoulders of Kwalkulh - Khawzawl road (International Corridor) of NH-6 from Design Chainage Km 72.350 to km 84.800 (Package-II) in the State of Mizoram under Bharatmala Pariyojna on EPC mode”.

Date: 26.03.2021 (05.10 PM)

Member Secretary apprised the Technical Evaluation Committee (TEC) that Technical Evaluation of responsive bids as per clause 3.1.6.1 of RFP was carried out by the TEC in its 1st meeting on 23.03.2021 at 04.30 PM (Minutes of Meeting is attached). After obtaining approval of the Competent Authority, the result of Technical evaluation was published on 24.03.2021 and the financial bids are scheduled to be opened on 27.03.2021 at 11:40 AM.

2. One Representation has been received from M/s. KPC Projects Ltd. mentioning that the bidder have the Experience certificate issued by client for the similar work but was not uploaded with the bid against the claimed project and only uploaded the certificate issued by Chartered Accountant due to oversight. The bidder submitted the Experience Certificate (copy enclosed) issued by the client. Accordingly, the Committee examined the certificate submitted by the bidder w.r.t. already claimed project under the eligible projects and recommended that the certificate may be considered for the similar work claimed by the bidder in its bid.

3. Also, one bidder namely M/s. JKM Infra Projects Ltd. was declared by the TEC as ‘Conditionally Eligible subject to submission of Authority’s certificate for similar work within 2 days’. The bidder has submitted the supporting documents vide letter dated 25.03.2021 (copy enclosed). The documents have been examined and TEC recommended that these documents may be considered for the similar work claimed by the bidder in its bid.

4. Considering above, TEC discussed and deliberated on the Technical bids of above two bidders and noted the following w.r.t. the eligibility criteria for technical qualification:
