Member Secretary apprised the Technical Evaluation Committee (TEC) that Technical Evaluation of responsive bids as per clause 3.1.6.1 of RFP was carried out by the TEC in its 1st meeting on 23.03.2021 at 05.00 PM (Minutes of Meeting is attached). After obtaining approval of the Competent Authority, the result of Technical evaluation was published on 25.03.2021 and the financial bids are scheduled to be opened on 27.03.2021 at 11:50 AM.

2. One bidder namely M/s. JKM Infra Projects Ltd. was declared by the TEC as 'Conditionally Eligible subject to submission of Authority's certificate for similar work within 2 days'. The bidder has submitted the supporting documents vide letter dated 25.03.2021 (copy enclosed). The documents have been examined and TEC recommended that these documents may be considered for the similar work claimed by the bidder in its bid.
