Detail reason for Non-responsiveness

1) M/s Chittaranjan Saha & Others

It is to mentioned that the as per Clause 4.6 of RFP, "Bid Capacity: - Bidders who inter alia meet the minimum qualification criteria will be qualified only if their available BID capacity is more than the total BID value". However, the bid capacity of M/s Chittaranjan Saha & Others calculated from the maximum value of civil work in last 5 years does not meet the minimum criteria for eligibility.

Calculated as BID capacity = (A*N*2.5 - B + C) (in crore): 7.57*0.25*2.5-0.99=3.74 Cr, taking into account maximum value of civil engineering work for FY 2023-24.

It is also to mentioned that the M/s Chittaranjan Saha & Others has not submitted "Self-clarification that the item offered meets the local content requirement for Class-I local Supplier, Class-II local Supplier as case may be" as per Cl 20.4 of Section-II (ITB) of RFP. Accordingly, the bidder is considered as "Non-Local Supplier".

As per Dept. for Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Public Procurement (Preference to make in India) order 2017 No. P-45021/2/2017-PP(BE-II) dated 16.09.2020 wherein as per Para 3 (b) states that "Only Class-I Local supplier and Class-II Local Supplier, as defined under the Order shall be eligible to bid in procurements undertaken by procuring entities, except when Global tender enquiry has been issued."

M/s Chittaranjan Saha & Others has not submitted Power of Attorney of the signatory of the bid to commit the bidder as per format attached in the Page no. 62 in the RFP.

Consequent to the above, the bid of M/s Chittaranjan Saha & Others is considered as Technically Non-Responsive.

2) M/s Vertex Construction

It is to mentioned that the as per Clause 4.6 of RFP, "Bid Capacity: - Bidders who inter alia meet the minimum qualification criteria will be qualified only if their available BID capacity is more than the total BID value". However, the bid capacity of M/s Vertex Construction calculated from the maximum value of civil work in last 5 years does not meet the minimum criteria for eligibility.

Calculated as BID capacity = (A*N*2.5 - B + C) (in crore): 98.9*0.25*2.5-67.42 = (-)5.6 Cr, taking into account maximum value of civil engineering work for FY 2022-23.

It is also pertinent to mentioned that as per Cl 4.2 (g) of Section-II (ITB) of RFP "Scanned document in support of evidence access to line (s) of credit and availability of other financial resource facilities (10% of Contract value), certified by bankers (not more than 3 months old)". M/s Vertex Construction has

Executive Director (P) Regional Office, Kohima MHIDCL, Nagaland submitted line of credit amounting to 0.50 Cr which is less than 10% of the Contract value (i.e., 10% of 6.05 Cr = 0.61 Cr).

Consequent to the above, the bid of M/s Vertex Construction is considered as **Technically Non-Responsive.**
