	For consider the request	Submitted relevant documents for all the claimed project	Examined all the documents submitted by the bidder and 5 projects are found to be eligible out of 7 claimed projects. Out of two projects not considered one (code b) was of building construction and the second one (code c) was a supply contract. Thus the technical threshold capacity of the bidder is now 42.49 Crore. The bidder does not meet threshold capacity.
