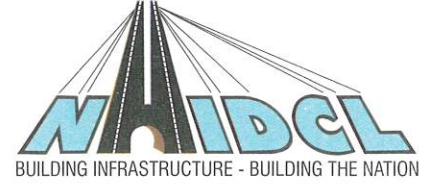

Having opened the Technical bids on 23.09.2021, Technical Evaluation Committee (TEC) met on 05.10.2021 to evaluate the proposals as per the terms of RFP document.

2. Member Secretary apprised that:

- a) As per clause 4.1 of Section-2 of RFP, bidders are required to submit their Technical Proposal only through online mode i.e. via CPP portal and INFRACON portal and no separate hard copy was required to be submitted.
- b) 05 (five) firms submitted their bids on Infracon Portal and CPP Portal by due date and time. Details of firms are as under:

3. The Committee noted that the Consultants had submitted their Technical Proposal on e-Procurement Portal i.e. on CPP Portal & INFRACON portal and the evaluation has been carried out based on the details submitted by bidders. The proposals were examined as per Section-2 (Letter of Invitation to Consultants) Data Sheet of RFP Document. Details of documents submitted by the bidders w.r.t Clause 4.1 (B) of RFP are attached at **Annexure-I**.





4. During the second stage evaluation, an anonymous complaint received regarding the Team Leader proposed by M/s Indian Tecnocrat Limited in association with Design Line Consultancy Services that the TL has submitted forged documents in respect of two projects at Sr. 9 and 11 of INFRACON. Thereafter, both the projects were verified from their respective consultants as per the certificate submitted by the TL, M/s Manglam Associates and M/s Planning & Infrastructural Development Consultants Pvt. Ltd. through email. In reply to which both the consultants denied that Mr. Raman Manohar has not worked with them on respective projects during the particular time period.

4.1 As per clause 3.4 (x) (a) of RFP, "if any information is found incorrect/fake /inflated in the CV, at any stage, debarment of the key personnel from future NHIDCL projects upto 2 years may be taken by NHIDCL". Hence, the proposal is non-responsive.

5. The technical evaluation of the above mentioned qualified firms were carried out. The key points observed during technical evaluation are summed up as follows:



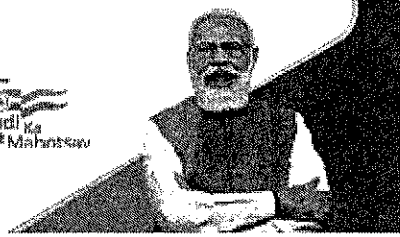
