2nd Minutes of Meetings of Technical Bid Evaluation Committee (TEC) for "Construction of North East Regional Office of National Highways & Infrastructure Development Corporation Ltd. at Guwahati, Assam on EPC mode" held at NHIDCL, New Delhi on 27.09.2021

With the approval of the Competent Authority the "Technical Evaluation Result" for the subject project was uploaded on CPP portal and NHIDCL website on 23.09.2021 mentioning that representation if any, should be submitted by 26.09.2021 by 02:00 pm.

2. During the evaluation of the bids the Committee in its first meeting opined that the following bidders have failed to meet the required criteria. The name of the bidders and reasons of failing have been provided below:

Sr. No.	Name of Bidders failing criteria	Remarks
1	M/S Garg Builders	Bidder could not fulfill the eligibility of successfully completed similar project required as per RFP Clause 2.2.2.2 (ii).
2	M/s I.S.Trading Co.	Bidder could not fulfill the eligibility of successfully completed similar project required as per RFP Clause 2.2.2.2 (ii).

3. One of the technically non-responsive bidders i.e. M/s Garg Builders vide letter dated 23.09.2021 has made a representation giving reference of the Clause 2.2.2.2 (ii) of the RFP reproduced as below:-

"The Bidder should have successfully completed "Similar Works" in previous five (5) years before the last date of the Bid submission as per the criteria specified below:

(a) 3 similar works each costing not less than the amount equal to 40% of the estimated cost put to this tender (i.e. Rs. 15.72 Crore), or

(b) 2 similar works each costing not less than the amount equal to 60% of the estimated cost put to this tender (i.e. Rs. 23.58 Crore), or


(c) 1 similar work costing not less than the amount equal to 80% of the estimated cost put to this tender (i.e. Rs. 31.45 Crore).

Definition of "similar work": The bidder should have completed Work of nonresidential public building (office /institutional /commercial etc.), under a single order in the preceding 5 years, reckoned from the due date of submission of the bid."


The bidder M/s Garg Builder has now submitted the following three works in respect of similar work criteria of three works with minimum value of Rs. 15.72 Crore:-

1	Construction of DCP Office and Staff Quarter at Sector-5 Rohini, New Delhi.	22,37,92,538/-
2	Construction of Academic Block and Service Building (1 st part of Phase-I) of the New College Building for Ramanujan College at Kalkaji New Delhi.	23,69,66,191/-
3	Construction of Administrative Building, Service Building, public utilities, transporters office and Station Building including allied works at MMLP Pantnagar, Uttarakhand.	16,64,44,946/-









4. The work at Sr. No. 1 of the table mentioned above, was not considered as the work included the construction of Staff Quarter which comes under residential building. However, the bidder M/s Garg Builder vide email dated 24.09.2021 has submitted the completion certificate from the client mentioning the cost of construction of DCP office as Rs. 18.90 Cr. The construction of DCP office is an official building and meeting out the criteria of similar work.

5. The Technical Evaluation Committee (TEC) after due deliberation opined as under:

1.	M/s Garg Builders	Submitted the relevant documents.	The bidder submitted the completion certificate from the client clarifying that the cost of construction of DCP office building component as Rs. 18.90 Crore, and considering this work the bidder is now fulfilling the similar work criteria of 3 similar works each costing not less than the amount equal to 40% of the estimated cost put to this tender (i.e. Rs. 15.72 Crore) Hence request may be acceptable.




7. The Technical Evaluation Committee (TEC) after due deliberation opined that 08 (Eight) eligible bidders should be considered for the financial opening.
