1. Consequent upon the approval of Competent Authority for Technical Evaluation Committee (TEC) 2nd Minutes dated 06.07.2021, the following bidders were declared technically responsive and financial bid of the subject project was scheduled to be open on 15.07.2021.

2. It was brought to the notice of Committee that the financial bid of: “Balance work for Four-laning of NH-39 Dimapur – Kohima Road from Design Km 152.490 to Km 166.700 (Existing Km 156.000 to Km 172.900), in the state of Nagaland under SARDP-NE through an Engineering, Procurement and Construction (EPC) Contract (Package-III)” was opened on 16.07.2021 at wherein M/s Oasis Technocons Limited was declared as L-1 bidder.

3. The Committee was also informed that M/s Oasis Technocons Limited JV M/s Vidya Infrabuild Pvt. Ltd. is already executing the project of “Up-gradation to Two Lane with Paved Sholuder from Km. 12+850 to Km. 20+300 of 7.450 Km. Length on Goha- Khellenai section and a link road to Goha Village of 2.016 Km on NH- 244 in Union Territory of Jammu & Kashmir on EPC” and the work is in progress.

4. As per clause 2.1.15 of RFP “The bidder including individual or any of its JV member, who are either having 2 (two) on-going EPC Project(s) in NHIDCL or on-going Project(s) worth of ₹ 500 Crore (Awarded Cost) or more in NHIDCL, as on date of financial bid opening, shall not be eligible to bid for this Project (Issuance of LOA will be considered as on-going project)”.

5. Since M/s Oasis Technocons Limited has 2 projects under them, hence the bid of M/s Oasis Technocons Limited is not eligible on account of Clause 2.1.15 of RFP for the above subject work and their financial bid should not be opened as stated above.




6. Accordingly, the Committee recommends to open the financial bid of the 9 (Nine) technically responsive bidders on 19.07.2021 after the approval of Competent Authority.
