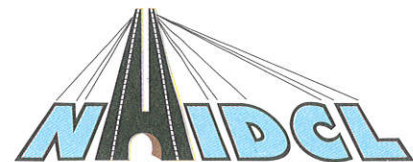

Proposals for subject project were invited from the prospective consultants with due date and time for submission as 14.12.2020 till 1100 hrs. Technical Evaluation Committee (TEC) met to open the Technical Proposals on 15.12.2021 at 1130 Hrs.

2. Following 10 (ten) firms submitted their bids online on the CPP Portal and Infracon Portal for the subject project by due date and time.

2. The Committee met on 09.08.2021 to finalize the 1st and 2nd stage evaluation. Following observations were noted by the committee: -

2.1 It was observed by the committee that M/s Lion Engineering Consultants Pvt. Ltd. vide NHAI letter no. NHAI/JH/BH/AE/2016/E-office file no. 71303 dated 08.06.2021 has been debarred for a period of 06 months from NHAI. Hence, committee decided to consider the letter issued by NHAI and declare M/s Lion engineering Consultants Pvt. Ltd. as non-responsive.

2.2 During 1st stage evaluation, committee noted that M/s Intercontinental Consultants & Technocrats Pvt. Ltd. in JV with Anandjiwala Infra Advisory Pvt. Ltd. is not eligible for 2nd stage evaluation as the JV Member is not meeting the minimum criteria for turnover.

2.3 It was noted by the committee that M/s SoWIL Limited in Association with ESPANA Consultants Pvt. Ltd. has not submitted their bid on e-procurement website and only uploaded on INFRACON Portal by due date and time. As per the clause 5 of NIT, "Bid must be submitted online at e-tender portal of NHIDCL <https://eprocure.gov.in> on or before the bid due date". Hence, as per the RFP, committee decided that M/s SoWil Ltd in Association with ESPANA Consultants Pvt. Ltd. is non-responsive for the subject project.




