NHAI/JH/BH/AE/2016/E-office file no. 71303 dated 08.06.2021 has been debarred for a period of 06 months from NHAI. Hence, committee decided to consider the letter issued by NHAI and declare M/s Lion engineering Consultants Pvt. Ltd. as non-responsive.






