4. Accordingly, the results of Technical Evaluation were uploaded on CPPP and NHIDCL website on 06.10.2021. The bidder M/s Shivam Condev Pvt Ltd vide letter dated 07.10.2021 has submitted a representation stating that , "we request you to kindly intimate us the cause of Rejection/Non-responsive of our bid before opening of financial bid i.e. 13.10.2021, 04:30 PM". While the Technical Division was processing the reply, a case was filed by M/s Shivam Condev Pvt Ltd listed on 12.10.2021 before the Divisional Bench of Delhi, High Court, wherein, after hearing the defense in the case presented by NHIDCL, Honb'le High Court directed to defer the financial opening, which was scheduled on 13.10.2021. (Copy of Honb'le High Court dated 12.10.2021 is as Annexure-A).

5. The committee was deliberated that the reason for Non-responsiveness of the bidder M/s Shivam Condev Pvt Ltd has now been communicated vide letter NHIDCL/Megh./N-R-K/Package-I/2020-Part (1)/2020/2117 dated 27.10.2021 and the same has also been uploaded on NHIDCL website. The reasons for non-responsiveness of the bidder as communicated to the bidder are as below:

(i) The Directors of the M/s Shivam Condev Pvt Ltd, Mr. Sourav Aggarwal and Mr. Ankush Aggarwal, who are, are also the Directors of 'M/s Siddhant Financial Services Pvt. Ltd.' which holds 14.98% shares in M/s ARSS Infrastructure Projects Pvt. Ltd. M/s Shivam Condev Pvt Ltd and M/s ARSS Infrastructure Project Ltd. are related parties having common directors through intermediary company M/s Siddhant Financial Services Pvt. Lt.

(ii) The firm M/s Shivam Condev Pvt Ltd and its related parties already have 2 of the following ongoing projects in NHIDCL which has not been disclosed by the bidder in documents submitted in response to Clause 2.1.15 of the RFP:

Since, the firm M/s Shivam Condev Pvt Ltd has been executing the abovementioned Sikkim Project with NHIDCL and its related Party M/s ARSS Infrastructure is also executing one project in Meghalaya with NHIDCL, as per provisions of Clause 2.1.15 of the RFP, Technical Bid of the bidder has been declared Non-Responsive for the aforesaid work.

(iii) The committee was also appraised that, the project "Construction and upgradation of existing road to 2-lane with paved shoulder from km 37 + 600 (New Rolep Bridge) to km 52+000 (Chochenpheri) of Rhenok-Menla spur (NH-717B) Package-IIC on EPC basis under SARDP-NE Phase 'A' in the State of Sikkim" executed by M/s Shivam Condev Pvt Ltd has been terminated by NHIDCL vide termination letter dated 16.03.2021, which also makes the firm as non-responsive as per clause 2.1.14 (xiii) of the RFP as the bidder M/s Shivam Condev Pvt Ltd has not only failed to disclose about the aforementioned projects, but have also furnished a false undertaking in Annex-IX & Appendix-IA in its bid submitted for the subject work.

6. The Committee opined that as per the provisions stipulated in Clause 2.19 of the RFP, more than 7 days have already been passed since the reason of non-responsiveness has been communicated to the bidder M/s Shivam Condev Pvt Ltd and no response has been received till the time of this meeting dated 05.11.2021 and hence, the result of Technical evaluation remains unchanged and is represented as under:-
