Technical Bid Evaluation Committee (TEC)

Name of work: Restoration and Repair of Helmet Top Realignment Road from 1.570 to km 2.570 by way of construction of R/Wall, Crate Wall, Box culvert and laying of WBM-III, BM and BC in the UT of Jammu & Kashmir for FY 2021-22.

Date: 08.11.2021.

Venue: NHIDCL-RO Jammu.

The bids for the subject work were invited on 01.10.2021 with Bid Due Date as 21.10.2021 with a completion period of 05 months. The bids were opened on 22.10.2021 at 16:00 Hrs in NHIDCL-RO Jammu. No representative of any of the bidders were present during the bid opening of the subject project.



2. The Technical Bid Opening Committee (TBC) has broadly determined the responsiveness of the bids with reference to BG/DD towards bid security, cost of documents and POA and deliberated that the following 03 nos. bids may be evaluated further for determination of technical responsiveness:

4. The Technical Evaluation Committee (TEC) met on 29.10.2021 to determine the technical eligibility of 03 nos. of bids with respect to conditions of RFP. As per recommendation of TEC, clarifications were sent to 03 nos. bidders.



5. The replies to clarifications have been received from all the 03 bidders within due date and time. TEC again met on 08.11.2021 to further evaluate the bids w.r.t the clarifications provided by the bidder, the details of the same are given as follows:

3.	M/s ABDUL RASHID BHAT AND SONS	(i) As per the provision of RFP, the similar work constitutes construction/maintenance of bituminous road work or/and construction of protection works (Retaining walls, Breast walls, Crate walls)/Fixing of metal crash barrier on National Highways/State Highways. The bidder is requested to clarify which work has been claimed towards similar work and whether the claimed work pertains to National Highway/State Highway. (ii) The bidder has not provided the Balance sheet and profit and loss statements for FY 2020-21. (iii) The bidder has not provided the required undertaking for validity of bid on notarised paper as per as per Section-III of RFP.	(i) Submitted (ii) Submitted (iii) Submitted	Accepted

6. The TEC noted the following:

(i) The bidder M/s Rajesh Kumar Contractor has not provided the information on the details of works for which bid is submitted and accepted. Further, the bidder does not qualify in the bid capacity and hence the TEC was of the opinion that the bidder may be declared as non-responsive.

(ii) With respect to the bidder, M/s Abdul Rashid Bhat and Sons, the bidder does not qualify towards similar work, as the similar work claimed by the bidder

does not pertain to National Highway or State Highway as per provisions specified in the RFP. The TEC was of the opinion that the bidder may be declared as non-responsive.

7. The following was observed by the TEC vis-à-vis the qualification criteria provided in the RFP to determine the technical responsiveness of the firms. The detailed evaluation sheet is attached as Annexure-I.
