

The bidder must have received contractual payments three financial years and the current financial year up to the date of opening of tender, at least 150% of the advertised value of the tender (Rs. 33.67 Crore). If the Audited Balance Sheet for the immediately preceding year is not available, audited balance sheets, profit and loss statements and other financial statements of the five financial years immediately preceding the previous year may be adopted for evaluating the credentials of the bidder.
