2nd Minutes of Meetings of Technical Bid Evaluation Committee (TEC) for: “Construction of two lanes with paved shoulders road from Tamenglong to Mahur in the state of Manipur from km 34+000 at Phelong to km 44+700 near Azuram (Package 4) on EPC mode” held at NHIDCL, New Delhi at on 19.03.2020.

1. Consequent upon the approval of Competent Authority for Technical Evaluation Committee (TEC) 1st Minutes dated 17.03.2020, the following bidders were declared technically responsive and financial bid of the subject project was scheduled to be open on 19.03.2020.

2. It was brought to the notice of Committee that the financial bid of: “Construction of two lane with paved shoulders road from Tamenglong to Mahur in the state of Manipur from km 0.000 at Tamenglong to km 10.000 near Dialong (Length-10.00km) (PKG-1) on EPC mode” was opened on 19.03.2020 at 11.00 hrs at wherein M/s Asean Agencies was declared as L-1 bidder.

3. The Committee was also informed that M/s Asean Agencies has already been awarded the project of “Construction of 2 Laning with Hard Shoulder of Peren - Dimapur section on NH - 129A from Design Km 126.775 to Km 146.208 (Length - 19.433 Km) in the state of Nagaland on EPC mode (Pkg - II) under NH(O) - TSP” vide LoA dated 13.01.2021.

4. As per clause 2.1.15 of RFP “The bidder including individual or any of its JV member, who are either having 2 (two) on-going EPC Project(s) in NHIDCL or on-going Project(s) worth of ₹ 500 Crore (Awarded Cost) or more in NHIDCL, as on date of financial bid opening, shall not be eligible to bid for this Project (Issuance of LOA will be considered as on-going project)”.

5. Since M/s Asean Agencies has 2 projects under them, hence the bid of M/s Asean Agencies is not eligible on account of Clause 2.1.15 of RFP for the above subject work and their financial bid should not be opened as stated above.

6. Accordingly, the Committee recommends to open the financial bid of the 8 (Eight) technically responsive bidders on 19.03.2021 after the approval of Competent Authority.
