One bidder i.e. M/s. Mathiyan Construction Pvt. Ltd. (MCPL) has submitted bids as a sole bidder as well as JV partner with M/s. APS Hydro Pvt. Ltd. However, bidder vide letter dated 23.03.2021 requested to consider the bid submitted as sole bidder null & void for the subject project. Bidder mentioned that this is happened because the bids were submitted for Package-1 and Package-4 of NH-302 on 04.03.2021 and later on an Amendment was published on 09.03.2021 vide which name and estimated cost of tender has been updated. Hence, the bidder submitted new bid as JV as per new increased qualification criteria due to increase in estimated cost and the old bid could not be withdrawn due to technical error and also, M/s. MCPL has not submitted the hard copy of old bid. As per clause 2.1.1 of RFP, "No Bidder shall submit more than one BID for the Project. A Bidder bidding individually or as a member of a Joint Venture shall not be entitled to submit another BID either individually or as a member of any Joint Venture, as the case may be". Accordingly, the request of bidder for null and void of old bid submitted as sole bidder may be considered because NHIDCL has clubbed the package-1, 2 & 3 into Package-A vide an Amendment dated 09.03.2021 after submission of bid by M/s. MCPL as sole bidder thereby increasing the estimated cost put to tender as well as qualification criteria. Considering the above, TEC agreed for the same.
