The Committee observed that all 5 out 6 (Six) bidders submitted the bid document fees of Rs. 47,200/- (Rupees Forty Seven Thousand Two Hundred Only) through online mode (RTGS/NEFT/other online mode considering difficulty in its physical submission due to COVID-19 situation) on online bid submission date. However, one of the bidder, M/s Viva Infraventure Pvt. Ltd. - M/s Nad Bindu Infratech Pvt. Ltd. has not paid the bid document fees as mentioned in tender document.
