The Committee observed that all 16 (Sixteen) bidders submitted the bid document fees of Rs. 23,600/- (Rupees Twenty Three Thousand and Six Hundred only) through online mode (RTGS/NEFT/other online mode considering difficulty in its physical submission due to COVID-19 situation) on online bid submission date.

6. The Committee observed that 02 (two) bidders M/s Satya Builders & M/s Dwarkamai Constructions Pvt. Ltd. have already emerged as L1 bidder in two works in NHIDCL. Therefore, as per RFP Cl. 2.1.15, technical bid of M/s Satya Builders & M/s Dwarkamai Constructions Pvt. Ltd. are not eligible for evaluation for the subject project. Accordingly, the Committee evaluated technical bids of remaining 14 (Fourteen) bidders.

7. The Committee in reference to RFP has considered the following Evaluation Criteria for estimated project cost of Rs. 107.13 Crore.
