4. **The Evaluation Committee** during evaluation found that some of the data/information provided by the Bidders are not adhering to the clauses given in the RFP document, so it was proposed that the clarification may be sought from the Bidders as per clause no 3.1.4 of the RFP to facilitate the evaluation process. Accordingly, the **Technical Evaluation Committee (TEC)** in its meeting has decided that the clarification as requested by the Technical Division is to be sought from the respective bidders.

5. It was brought to the notice of the committee that M/s Arvind Aviation has submitted blank pages in the bid due to which the bid has been considered as non responsive, therefore no clarification is required.

6. In Continuation to 1<sup>st</sup> Meeting of **Technical Evaluation Committee (TEC)** held on 09.04.2021, replies received from the bidders, the Evaluation report were deliberated by the TEC in 2<sup>nd</sup> meeting held on 15.04.2021. Some of the bidder has not given the year wise break up of receivable value for civil work reflected in the UDIN Certificate however the value given by the statutory Auditor have been considered.
