Minutes of Meeting of Technical Evaluation Committee (TEC) to evaluate the Technical bids for Selection of Consultants for Authority's Engineer for "Design, Engineering, Procurement, Supply and Construction of Four Lane Bridge Including Approaches Over River Brahmaputra between Dhubri on North Bank and Phulbari on South Bank in The State of Assam / Meghalaya on NH-127B (Length: 19.282 km)"- held at NHIDCL HQ, New Delhi on 11.12.2020.

The Technical Evaluation Committee (TEC) reviewed the observation of JICA received vide letter no. JICA (ID) 2020 - 623 dated 10.12.2020 in response to NHIDCL letter no. 617 dated 04.12.2020, wherein JICA sought nationality of the shortlisted consultants and has pointed out some typographical error in the Minutes of Meting dated 02.12.2020.

2. The committee observed that the score derived in the minutes were based on the computer excel sheet which was rounded off to two digit after decimal, however on manual calculation this resulted in error of 0.02 scored on plus (+) side. Accordingly, the technical score of the firm has been modified. Further, the detail of nationality of the firms are given below:

- 3. The RFP for the subject work was invited on CPP Portal on dated 07.10.2020 with Bid due date 05.11.2020. The bid submission date was further extended to 19.11.2020 on the request of the Bidders due to Pooja holidays and COVID-19 issues. Subsequently the technical bids were opened on 20.11.2020.
- 4. Technical Evaluation Committee (TEC) opened the Technical Bids online through the CPP portal on the scheduled date and time. No Representatives of the bidder attended the opening of the technical bid.
- 5. On opening of the Bids online through CPP Portal, the Committee observed that the following 2 (Two) nos. of Bidders submitted their proposal online on the CPP Portal against the subject project;
- (i) M/s AECOM Asia Company Ltd. in association with M/s PADECO Co. Ltd.
- (ii) M/s Systra S.A.
- 6. As per the Cl. 9 of Section 1 of RFP, the Consultants paid the non-refundable fee of Rs. 5,900/- (inclusive of GST) towards cost of RFP at the time of the submission of the Bid proposal through RTGS/NEFT/other digital mode in the given bank details of NHIDCL on or before 19.11.2020, (1500 hrs). Proof of payment has been uploaded online along with bid documents.

- 7. Member Secretary appraised that:
 - a) As per Clause 28 of Section-1 of RFP, bidders are required to submit their Technical Proposal only through online mode i.e. via CPP portal and documents mentioned in Clause 10.1 (v) of QCBS-Data Sheet of Section-2 of RFP have been submitted in original.
 - b) The details of firms are as under:

- 8. The Committee noted that the Bidders as per the Clause 28 of Section-1 of RFP, submitted their Technical Proposal on e-Procurement Portal i.e. on CPP Portal and the evaluation has been carried out based on the details submitted by bidders. The proposals were examined as per QCBS Data Sheet of RFP Document.
- 9. While evaluating the technical proposal of the Bidders, the Committee observed the following;
 - (i) That the designation of the Key Experts claimed in their CVs as stated under the qualification criteria of the RFP under similar category differs. The Committee after examining the proposal w.r.t. the size of project, nature of responsibility claimed by the Experts meets the technical qualification criteria of the respective key Experts and therefore accepted the same.
 - (ii) That the Key Experts have claimed projects for their professional experience in cable stayed, cable suspension, extra-dosed, prestressed bridge and via-ducts for bridge type in their CV. The Committee after examining the projects considered the claimed projects in the technical qualification criteria of the respective key Experts.
 - (iii) That in one of the position of the Key Expert i.e. Senior Contract Expert has claimed experience in bridge as well as other infraprojects for the experience in his CV. The Committee after examining the projects considered the experience claimed by the expert based on his multi-experience in handling large infrastructure contracts.

- The Committee observed that one of the Bidder viz. M/s Systra S.A, 11. wherein the Chief QA & QC Engineer (International/National) and Chief O & M Expert (International/National) do not meet the eligibility criteria as per the Cl. 29 (x) (f) Section 1 of RFP. Accordingly, in case the said firm is H-1, then all such Key Experts (whose CV scores less than 75% or who does not fulfil the minimum qualification) will have to be replaced by the firm before signing the contract.
- 12. Technical Evaluation Committee based on the deliberations and the scores obtained found both the bidders technically responsive and the Committee agreed and recommended for opening of the financial proposal of both the following technically eligible bidders;
- (i) M/s AECOM Asia Company Ltd. in association with M/s PADECO Co. Ltd. and
- (ii) M/s SYSTRA S.A.

13. Technical Evaluation Committee further recommended seeking approval of the Competent Authority, NHIDCL and concurrence of JICA for uploading of the technical evaluation result of the above technically responsive bidders on the CPP Portal and for opening of the financial Bids.
