Minutes of Meeting of Technical Evaluation Committee (TEC) to evaluate technical bids for "Construction and Installation of prefabricated Office cum Residence in the States of Himachal Pradesh & Union Territory of Ladakh in high altitude remote areas (Package-II)".

Date & Time: 18.12.2020 at 04:30 PM

Venue: NHIDCL, New Delhi.

The Member Secretary apprised the committee that based on the recommendation of TEC in its 1st meeting held on 16.12.2020, clarifications were asked from two bidders on 16.12.2020 for furnishing the reply by 18.12.2020.

2. Both the bidders i.e. M/s. E-Pack Polymers (P) Ltd & M/s. BNAL Prefabs Pvt Ltd submitted the reply of clarification on 17.12.2020. The bidder M/s. E-Pack Polymers (P) Ltd clarified and submitted the required undertaking which was submitted by the bidder only with physical bid and the other bidder M/s. BNAL Prefabs Pvt Ltd has provided the Balance Sheets for three years (FY2016-17, FY2017-18 & FY2018-19) in support to their claim of turnover certified by the Statutory Auditor.

3. Based on the reply received from the bidders, TEC evaluated the technical bids as per provisions of the RFP based on the documents uploaded by bidders on e-procure portal and noted the following (The detailed assessment is placed at Annexure-I):

4. M/s. Nipani Infra and Industries Pvt. Ltd. vide letter dated 16.12.2020 has submit a complain and mentioned that M/s. E-Pack Polymers (P) Ltd has provided false financial credential w.r.t. Construction works executed. The same has been examined and it is observed that the turnover includes sale/supply of pre-fabricated materials and installation charges which is also reflected in the balance sheets of other bidder i.e. M/s. Hindustan Windows Mfg. Co. Since the construction work of pre-fabricated structure includes supply of pre-fabricated materials and its installation, hence it can be considered.

5. After due deliberations, TEC agreed and recommended for opening of financial proposals of the following 03 (three) firms after obtaining approval from the Competent Authority:

- (i) M/s. Nipani Infra and Industries Pvt. Ltd.
- (ii) M/s. E-Pack Polymers (P) Ltd
