The bids for the subject work were invited on 15.07.2024 with Bid Due Date as 14.08.2024 and modified bid due date as 10.09.2024 (1200 Hrs) with a completion period of 09 months.

2. Duly constituted Technical Bid Opening Committee (TBC) met to open the technical Bids on 11.09.2024 (19:13 Hrs). No representative of the bidders was present during the technical bid opening (Attendance sheet attached).

3. The Technical Bid Opening Committee (TBC) has broadly determined the responsiveness of the bids with reference to BG/DD towards bid security, cost of documents and POA and deliberated that the following 13 nos. bids may be evaluated further for determination of technical responsiveness (as 04 Nos of bids could not be opened as per Clause 2.15.2 of Section-2 (Instruction to Bidders) & para-3.1.2 of Section-3 of RFP):

a) <u>M/s Akhter Hussain Lone :</u>

With respect to the bidder M/s Akhter Hussain Lone, clarification with respect to the eligible works claimed towards threshold technical capacity was asked. As per the clarification received from the bidder, the total value of the works claimed towards the threshold technical capacity works out to be Rs. 8.40 Cr which is less than the required Threshold technical capacity of Rs. 11.24 Cr. Further as per the details of turnover and ongoing works the bidder does not qualify for the bid capacity. Moreover, the bidder has submitted contradicting documents bearing same reference number and with the same date, which depicts the misrepresentation of information, hence the same has not been considered by the committee.

Considering the above, TEC was of the opinion that the bidder, M/s Akhter Hussain Lone may be declared as non-responsive. 7. The completion certificate towards the similar work submitted by the 12 Nos of bidders were sent to the respective clients for verification. TEC examined the same, the details of which are follows:
