3	M/s Madhucon Projects Limited	Non- Responsive	As per RFP Section 2 clause 2.1.18 the EPC Contractor will not be considered for evaluation if they are declared as Non-Performer as the RFP mandates that "Upon declaration of non-performer/debarred, the Contractor/Concessionaire will not be able to participate in any bid for National Highways projects with MoRTH or its executing agencies till such time the debarment persists or the contractor/Concessionaire is removed from the list of Non-performer. IN bidding for a particular project, bids from only such firms should be considered for placement of Contract, which are neither debarred on the date of opening tender nor debarred on the date of issue of Letter of Acceptance (LoA). Contracts concluded before the issue of the debarment/declaration as non-performer order shall not be affected by the debarment order(s) issued subsequently." In this regard it was observed that M/s Madhucon Projects limited has been declared Non-Performer in Chakabama-Zunheboto (Package-V) in the state of Nagaland on 10.01.2023. Keeping in view Para 2.2.18 of the RFP, it has been decided to declare the bid of M/s Madhucon Projects Limited as Non-Responsive.

6	M/s Panwar Construction Company	Non-Responsive	As per RFP Section 2 clause 2.11.2, Bidder was required to submit the documents physically by the date and time as mentioned in the NIT, RFP Section 7 Data Sheet. However, M/s Panwar Construction Company has not submitted any documents physically. Further, the bid security, document fees & majority of critical documents required to evaluate the bid were not uploaded on the CPP Portal. Keeping in view RFP section 3 clause 3.1.6 which states that "A Technical BID shall be considered responsive only if the documents are received" and RFP Section 2 clause 2.13 which states that "Physical receipt of documents listed at clause 2.11.2 of the RFP after the prescribed date and time given in the Data Sheet shall not be considered and the bid shall be summarily rejected". However, M/s Panwar Construction Company one of the bidders has not submitted the documents physically as listed in RFP section 2 clause 2.11.2, along with Original Bid Security. Therefore the bid has been considered as Non-Responsive.

2. The bidders are requested to submit their representation if any, within 7 days i.e. up to 24.01.2023 at 1700 hours in NHIDCL HQ, New Delhi.
