7.3 M/s ABDUL RASHID BHAT AND SONS:

7.4 M/s SAGINA BUILDERS:

The bidder has submitted completion certificates for 03 works towards qualifying similar work from which 02 works pertain to PMGSY road and the remaining work pertains to ODR. Therefore, it has been concluded that the bidder does not qualify in similar nature of work.

7.5 M/s DUWA CONSTRUCTIONS:

The bidder has claimed that 09 works has been executed till date, for which completion certificates has also been submitted. However, all the claimed works pertain to PMGSY road and no work has been executed for NHs/SHs as per provisions of RFP. Therefore, it has been concluded that the bidder does not qualify in similar nature of work.

8. TEC deliberated on the clarifications received from the bidders with the following observations given below:

8.1 M/s SAGINA BUILDERS:

The following shortfalls has been observed with respect to the bidder, M/s Sagina Builders:

- The qualification information as per Section-III of the RFP has not been provided.
- The details of the ongoing works have not been provided.
- The details of the works for which bid is submitted and accepted but contract signing is pending has not been provided.
- The experience of the key personnel as per clause (4.4) (B) (b) (ii) of the RFP has not been provided. Further, the detailed, signed and scanned CV of the Project Manager has also not been provided.
- The form of letter of application has not been provided.
- The notarized undertaking for 120 days Bid Validity as per Section-III of RFP has not been provided.
- The authentic CA certificate with a valid UDIN No has not been provided.
- The balance sheets supporting the Turnover for FY 2020-21 and 2021-22 has not been provided.
- The bidder does not qualify in similar nature of work.

Considering the above, the committee is of the opinion that the bidder, M/s Sagina Builders may be declared as non-responsive.

8.2 M/s DUWA CONSTRUCTIONS:

The following shortfalls has been observed with respect to the bidder, M/s DUWA CONSTRUCTIONS:

- The qualification information as per Section-III of the RFP has not been provided.
- The LOA of the ongoing works have not been provided.
- The details of the works for which bid is submitted and accepted but contract signing is pending has not been provided.
- The experience of the key personnel as per clause (4.4) (B) (b) (ii) of the RFP has not been provided. Further, the detailed, signed and scanned CV of the Project Manager has also not been provided.
- The balance sheet for FY 2020-21 not provided and there is a mismatch in the turnover for FY 2021-22 with the Balance sheet.
- The bidder does not qualify in similar nature of work.

Considering the above, the committee is of the opinion that the bidder, M/s DUWA CONSTRUCTIONS may be declared as non-responsive.
