- 3. Empowered Technical Bid Evaluation Committee (ETBC) opened the bids on 17.06.2020. Further, the technical evaluation of the bids were carried out by Empowered Technical Bid Evaluation Committee (ETEC) on 30.06.2020.

- 4. After due deliberation of the bid, it was found that M/s General Highways and Infracon Private Limited is non-responsive as the bidder has not submitted any requisite work experience as per the requirement of RFP. Further, M/s Eptisa India Private Limited in JV with Eptisa Servicios de Ingeneria is non-responsive as no requisite experience certificate of the Lead Member i.e. M/s Eptisa India Private Limited has been submitted.
- 5. Further, it has been observed that although the bidders have submitted the CVs of the key personnel, however, some bidders have not submitted the educational certificates of the proposed key personnel and none of the bidders have submitted the supporting experience certificates of the key personnel as per the requirement of RFP.
- Exaministic was informed that there is an emergency in the matter as Govt of Jammu & Kashmir is pressing hard for the empanelment of consultants for preparation of DPR for water Supply Scheme under Jal Jeevan Mission in J&K. Considering the exigency of work, it has been recommended that the educational certificates and experience certificates of the key personnel proposed by the bidders be deferred at this point of time, since it is an empanelment stage only. For the current purpose of evaluation, only the number of key personnel proposed by the bidders is to be checked and if the number of key personnel are as per the requirement of the RFP, then full marks be allotted to the key personnel as per the provision of the RFP. However, at the time of invitation of financial bids from the empanelled consultants, the empanelled Consultants shall have to submit the CVs of the key personnel supported with educational certificates as well as experience certificates of the proposed key personnel. Further, it has been observed that UDIN no. on the Annual Turnover Certificate issued by the CA of M/s Venkateshwara Enterprises and M/s Exceltech Consultancy & Projects Pvt Ltd is not mentioned, hence, the bidders be requested to submit the same at the time of submission of financial bids.
- 7. Accordingly, the Second Stage Evaluation of the 12 (twelve) responsive bidders with respect to *Clause 5 of NIT*: Evaluation Methodology was carried out as under. Details of the marks obtained by the bidders is placed at Annexure-I.
