

In the document submitted by the bidder online, the name of project has been indicated as <b>"Restoration of Road by construction of Pucca Drain in selected stretches from K.m. 0.000 to K.m. 170.000 on Batote -Kishtwar- Sinthan Pass Road on NH-244 in the Union Territory of Jammu &amp; Kashmir"</b> instead of subject project.</p> <p>2. In Bid Security submitted online, the name of the project has been indicated as <b>"Restoration of Road by construction of Pucca Drain in selected stretches from K.m. 0.000 to K.m. 170.000 on Batote -Kishtwar- Sinthan Pass Road on NH-244 in the Union Territory of Jammu &amp; Kashmir"</b>. The bidder has submitted Bank Guarantee of Rs. 12,50,000/- and Demand Draft of Rs. 10,000/- as against the requirement of Rs. 37,34,000/- and Rs. 15,000/- respectively (refer NIT) for the subject work. Thus, the bidder is non-responsive as per Clause 16.2 &amp; 16.3 of Section II of ITB.</p> <p>3. As per submitted bid documents, the bidder has no eligible similar work on NH/SH for Rs. 746.81 Lakhs as per Clause 4.4 (b) of Section II of ITB.</p> <p>Thus, the bidder is not Technically Qualified and is not eligible for opening of Financial Bids.</p>
