Detailed Reasons for Non-Responsiveness

1. M/s T Tachu & Co. - M/s YFC Projects Private Limited (JV)

The bidder, M/s T Tachu & Co.-M/s YFC Projects Private Limited (JV) does not have similar work experience of 20% of Estimated Project Cost having minimum 60 m of total length of Box Pushing with 30.8 m cross sectional area and 30 m minimum pushing at one place. The other member, M/s YFC Projects Private Limited has claimed one project i.e. code 'A', construction of Twin Box Tunnel by box pushing method having length of 89 m with cross sectional area of 76.247 m. However, in the client certificate, the value of work executed for construction of twin box tunnel by box pushing method is not mentioned. Also, as per client certificate, it cannot be ascertained whether the value of work done by the bidder as on 31.03.2023 is more than 90% completed. Hence, the project has not been considered for the experience of similar work. Accordingly, the bidder, M/s T Tachu & Co.-M/s YFC Projects Private Limited (JV) is non-responsive as per Cl. 2.2.2.2 (iii) (c) & 2.2.2.4 (ii) of RFP.

2. M/s Jandu Construction India Private Limited-M/s Godara Construction Company (JV)

The bidder, M/s Jandu Construction India Private Limited-M/s Godara Construction Company (JV), does not fulfil the minimum bid capacity as required under Cl. 2.2.2.1 of RFP. As per assessment, the lead member has total bid capacity of Rs.(-) 375.44 Cr. against the minimum requirement of Rs. 49.986 Cr. Accordingly, the bidder, M/s Jandu Construction India Private Limited-M/s Godara Construction Company (JV) is non-responsive as per Cl. 2.2.2.1 & 2.2.2.4 (i) of RFP.

3. M/s KKB Projects Pvt. Ltd. - M/s Jay Jawan Construction Co. (JV)

The bidder, M/s KKB Projects Pvt. Ltd. - M/s Jay Jawan Construction Co. (JV) does not have similar work experience of 20% of EPC having minimum 80 m of total length of Cast in Situ/Box Pushing/Pre-Cast with 30.8 m cross sectional area. The other member, M/s Jay Jawan Construction Co. has claimed one project i.e. code 'a', RCC Box Cell by box pushing method having length of 100.80 m with cross sectional area of 50.4 m, project cost Rs. 26.86 Cr. However, as per client certificate, bidder had executed the work in JV and the share of the bidder in the project was 49%. Therefore, the value of work executed by the bidder comes out to be Rs. 13.16 Cr and after applying the up-dation factor, the project cost is assessed as Rs 13.82 Cr against the minimum requirement of Rs.16.66 Cr. Accordingly, the bidder, M/s KKB Projects Pvt. Ltd. - M/s Jay Jawan Construction Co. is non-responsive as per Cl. 2.2.2.2 (iii) (c) & 2.2.2.4 (ii) of RFP.
