It is recommended to apprise bidder the page no. in the bid where the same is submitted.
2	M/s Deepali Designs and Exhibits Pvt Ltd	Technically Non-Responsive	The balance sheet submitted by M/s Deepali Designs and Exhibits Pvt Ltd in their bid is not clear and it is difficult to ascertain Net worth & Average Annual Turnover. Moreover, bidder is not having one similar completed work as per clause 4.4 (A) (i) and also not having experience of building of minimum 2 floors with composite construction technology as per clause 4.4(A)(ii) of RFP. Therefore, the bid of M/s Deepali Designs and Exhibits Pvt Ltd is Technically Non- Responsive.
3	M/s Lloyd Insulations (India) Pvt Ltd	Conditionally Responsive subject to SFMS confirmation and submission of notes to accounts. Technically	In case of M/s Lloyd Insulations (India) Pvt Ltd., note no. mentioned in Revenue from operations in Profit & loss A/c to ascertain Average Annual Turnover is given. But notes to accounts could not be located in the bid. It is recommended to apprise bidder page no. in the bid where the same is submitted.
4	M/s Svam Infratel Private Limited	Technically Non-Responsive	In the instant case of Svam Infratel Private Limited the note no. referred in balance sheet of financial year 2021-22

			could not be located in the submitted bid. The Average Annual Turnover for last 2 years amounts to Rs. 0.33 Cr. against the required Turnover of Rs. 18.90 Cr. as per clause 4.4 (A) (a) of RFP. Also, Bid Capacity claimed by the bidder could not be located in the bid. Further, the bidder is not having experience of building of minimum 2 floors with composite construction technology as per clause 4.4 (A) (ii) of RFP. Therefore, the bid of M/s Svarn Infratel Private Limited is Technically Non- Responsive.
