- 9. To participate in bidding process, bidder must get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidder can get above mentioned digital certificate from any approved vendors. The Bidder, who already possess valid (DSC)" Digital Signature Certificate" need not to procure new Digital Signature Certificate.
- 10. The bidders should submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature. No proposal (Except the documents as mentioned in point 7 above) will be accepted in physical form. No other mode shall be accepted.
- 11. Bids will be opened online as per time schedule mentioned at Sr. No. 19.
- 12. Before submission of online bids, bidder must ensure that scanned copy of all the necessary documents have been attached with bid.
- 13. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
- 14. All the required information for bid must be filled and submitted online.
- 15. Bidders should get ready with the scanned copies of cost of documents & Bid Security declaration as specified in the tender documents. The original instruments in respect of cost of documents, Bid Security declaration and relevant documents will be submitted to the Tenders Inviting Authority by Registered post/courier/by hand before issue of LOA as per MoRTH circular no RV/NH-37010/4/ 2010- EAP(Printing) Vol. IV dated 30.04.2020.
- 16. The details of cost of documents, Bid Security declaration specified in the tender documents should be the same, as submitted online (Scanned copies) otherwise bid will not be accepted.
