The EMD and PBG are generally requested for the tenders offering the committed business to the bidders, Hence, the condition of EMD & PBG may be waived-off considering the nature and scope of above RFP. The presumption that these are prescribed for tenders offering committed business do not appear to be correct as no such orders/GFR provision are found. Hence, not possible to agree to the request.

Clause 12	12	NHIDCL may please clarify the allocation of flying commitments in case of multiple operators are empanelled and the method to ensure the equal business to all the operators, against the total flying to be conducted in a particular year. In the Aviation Industry, Helicopters and Fixed Wing are completely 2 different sectors as the functioning of both type of Aircraft is different from each other. There are only few operators, who have the NSOP endorsed for both the type i.e. Helicopters and Fixed Wings. Hence, the RFP Document shall favour only such handful NSOP Operators barring major Helicopter Operators like Pawan Hans to participate against the RFP.	The requirement of NHIDCL is for award of contract to a service provider who can provide services of Fixed Wing Aircraft as well as the Rotary Wing Helicopters. The BoQ is for providing of rates for both type of flying. Hence, if the contract is awarded to a single service provider, endorsement of both is required on the NSOP permit. We have checked from the
