Minutes of Meeting of Empowered Financial Evaluation Committee (EFEC) dated 31.03.2020 for "Rehabilitation and up-gradation of road from design km 0.000 to km 16.290 (Total length: 16.290 km) of Manu-Lalchara section on NH 44A to two lane with paved shoulder in the state of Tripura on EPC basis (Package-I)" held at NHIDCL, New Delhi on 31.03.2020

Having opened the financial bids of technically responsive bidders online through CPP Portal by EFBC on 30.03.2020 at 15:00 hrs, the financial bid has been evaluated and report is being submitted accordingly.

2. EFEC noted the financial quote of the bidders as under:

3. The Empowered Financial Evaluation Committee (EFEC) discussed in detail the financial bids of the technically responsive bidders and observed as under:-

- The bid price Rs. 166,94,16,314/- (Rupees one hundred Sixty Six crore ninety four lakh sixteen thousand three hundred and fourteen only) quoted by M/s Engineering Projects India Ltd (which is 0.48% below) than the estimated cost of Rs 167.75 crore is the lowest quote among all the bidders. Therefore, the same is the lowest bidder as per clause 1.2.6 of the RFP and is recommended as selected bidder as per clause 3.3.1 of the RFP.
- The Committee further observed that the bid price of the selected bidder i.e M/s Engineering Projects India Ltd is lower by less than 10% with



- respect to the estimated project cost (i.e Rs. 167.75 Cr.). The bidder shall furnish only performance security of 5% as per clause 2.21.1 of the RFP.
- iii. The selected bidder **M/s Engineering Projects India Ltd** has to furnish a performance security of 5% amounting to Rs. 8,35,00,000/- (Rupees Eight Crore thirty five lakh only)

4. It was brought to the notice of the committee that AA&FS of the subject project under number - A-12025/23/2019/Tri-NHIDCL Cell dated 13.03.2020 having a total project cost of Rs. 178.43 Cr has been obtained.


5. Committee, after deliberation, recommended to award the work to selected bidder i.e **M/s Engineering Projects India Ltd** at the quoted price of Rs. 166,94,16,314/- (Rupees one hundred Sixty Six crore ninety four lakh sixteen thousand three hundred and fourteen only) with performance Bank Guarantee of Rs. 8,35,00,000/- (Rupees Eight Crore thirty five lakh only) after approval of Competent Authority

1. Based on the report of the Technical Evaluation, the Empowered Technical Evaluation Committee (ETEC) in its meeting dated 26.03.2020 recommended opening of the financial bids of all the six Technically Responsive Bidders viz M/s SATISH PRASAD; M/s Engineering Projects India Ltd; M/s Hindustan Construction Co. Ltd - VCCL JV; M/s RAM KRIPAL SINGH CONSTRUCTION PRIVATE LIMITED; M/s Rajendra Singh Bhamboo Infra Pvt. Ltd; M/s DIPAYAN PAUL AND CHANCHAL PAUL JV. After obtaining the approval of the Competent Authority, the bidders were informed the schedule of the Financial Bid opening date i.e. 30.03.2020 at 15:00 Hrs as per clause 3.2 of RFP.

2. The Empowered Financial Bid Opening Committee (EFBC) opened the Financial Bids of all the six technically responsive bidders viz. viz M/s SATISH PRASAD; M/s Engineering Projects India Ltd; M/s Hindustan Construction Co. Ltd - VCCL JV; M/s RAM KRIPAL SINGH CONSTRUCTION PRIVATE LIMITED; M/s Rajendra Singh Bhamboo Infra Pvt. Ltd; M/s DIPAYAN PAUL AND CHANCHAL PAUL JV. None of the technically responsive bidder or their authorized representative attended the meeting. Attendance sheet enclosed herewith.


