Sub: Minutes of meeting of the Evaluation Committee held on 08.06.2020 for Evaluation of Technical Proposal of "Maintenance & Repair of Ravongla-Legship road Km 32+500 to Km 58+800 on NH-510 in the state of Sikkim on (Item Rate Contract)"

1. Evaluation Committee:

2. Bids for the above mentioned work was invited with due date as 01.06.2020 on e-Tendering mode. Till due date and time of Bid submission, Bids from following four bidders were received on e-tendering mode also they have submitted copy of document as asked in Cl.12.2 of RFP document.

- M/s Mahabir Prasad Agarwal
- M/s NLM Infra Projects
- M/s Parka Enterprises
- M/s Santalall and Brothers

3. The Committee in its meeting held on 02.06.2020, opened the technical proposal physically and verified from e-Tendering mode and found that all the bidders has submitted the bid document fee i.e. Rs 10,000/- in the form of DD, POA(except M/s NLM Infra Projects), affidavit & Bid Security declaration as per Cl. 12.2 of ITB.

4. The committee evaluated the Technical proposal of all the four bidders as per eligibility criteria mentioned in section of 4.2 of ITB of RFP.

(i) Committee found that M/s NLM Infra Projects is found to be technically Non-Responsive as the bidder is not meeting the eligibility criteria as per Clause 8 of ITB under Section II of RFP "The bidder including individual or any of its JV member, who are either having 2 (two) on-going EPC Project(s)/Maintenance work in NHIDCL or on-going Project(s) in Sikkim as on date of bid submission, shall not be eligible to bid for this Project (Issuance of LOA will be considered as on-going project)" as firm has already have two projects with NHIDCL.

(ii) Committee also found that the machinery details submitted by M/s Mahabir Prasad Agarwal in their bid document were not in physical possession, M/s Mahabir Prasad Agarwal as the machinery has been leased to M/s Parka Enterprises before bid due date. Therefore, as per Cl. 4.2(d) of ITB under Section II of RFP, M/s Mahabir Prasad Agarwal is not responsive.


(iii) Two bidders i.e. M/s Parka Enterprises and M/s Santalall and Brothers meeting the desired eligibility criteria and committee found these two bidders as responsive.

5. The committee further evaluated the criteria as per Cl. 4.4 for ITB of RFP for responsive bidders Viz M/s Parka Enterprises and M/s Santalall and Brothers and found to be Technically responsive (details enclosed at Annexure-I).

6. Committee recommended for opening of Financial Proposals of Technically Qualified Bidders viz. M/s Parka Enterprises and M/s Santalall and Brothers after the approval of Competent Authority.
