1. Bids for the subject work were invited on 30.04.2020 with Bid Due Date on 04.06.2020.
2. Based on the Technical Evaluation of the Bids received and approval of the Competent Authority, Technical Evaluation result for the subject work is as under:

3. In view of the above, the qualified Consultants are hereby empanelled initially for a period of 02 (two) years extendable for a further period of 01 (one) year at the discretion of NHIDCL on the same terms & conditions.

Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) for evaluation of Technical Bids for the work of “Empanelment of consultants for Comprehensive Flood Management or River Training works/Canal Works/River Front Development to be carried out in various parts of India including J&K” at NHIDCL HQ, New Delhi on 28.08.2020.

1. Bids for the subject work were invited on 30.04.2020 with Bid Due Date on 04.06.2020.
2. In all, 5 (Five) bids were received from the following firms online till the scheduled Bid Due Date.
  - i. M/s Tractebel Engineering Pvt. Ltd.
  - ii. M/s Exceltech Consultancy and Projects Pvt. Ltd.
  - iii. M/s Tata Consulting Engineers Limited.
  - iv. M/s Egis India Consulting Engineers Private Limited.
  - v. M/s Eptisa India Private Limited.
3. Empowered Technical Bid Opening Committee (ETBC) opened the bids on 05.06.2020. Further, Technical Evaluation of the Bids was carried out by The Empowered Technical Bid Evaluation Committee (ETEC) on 16.07.2020.
4. After due scrutiny of the bids, the Committee found that 02 bidders i.e. M/s Exceltech Consultancy and Projects Pvt Ltd & M/s Eptisa India Private Limited in JV with Eptisa Servicios de Ingenieria had not submitted the requisite work experience as per the requirement stated in RFP. M/s Exceltech had submitted work experience of water Supply/ Sewage treatment, and M/s Eptisa had submitted the work experience of only the JV partner i.e. Eptisa Servicios de Ingenieria, S.L. (Spain). Hence it was recommended that both the bidders may be disqualified.
5. Further, it was observed that although the bidders had submitted the CVs of key personnel, some bidders had not submitted the supporting experience certificates of the key personnel.
6. In view of the above, necessary clarifications were sought from the following bidders with the approval of Competent Authority.
  - i. M/s Tractebel Engineering Pvt. Ltd.
  - ii. M/s Tata Consulting Engineers Limited
  - iii. M/s Egis India Consulting Engineers Private Limited.
7. M/s Tractebel Engineering Pvt. Ltd. & M/s Egis India Consulting Engineers Private Limited have submitted the necessary clarifications vide email. However, M/s Tata Consulting has not submitted the clarifications that were sought from them till date. Numbers of attempts were made to contact the concerned via email & telephone but no response for the same has been received.
8. Keeping in view the above, the committee recommends that M/s Tata Consulting should be disqualified as no clarifications have been received from their end.

9. Accordingly, Evaluation of the 2 (two) responsive bidders with respect to “Clause 5 of NIT: Evaluation Methodology” was carried out and the brief detail is given in the following table. The Details of marks obtained by the bidders is placed at Annexure-I.
