(a) Similar nature of services means providing manpower services of skilled and unskilled manpower for routine office work in Govt. organization/Public Sector organizations/Autonomous Body, Private Sector of repute only, but does not include security services, catering services etc.

(b) A bidder should secure mandatory of a minimum of 70% marks (i.e. 70 marks out of total 100 marks as per table) in Technical Evaluation in order to be a qualified bidder for being eligible for Technical weightage and subsequently for opening of financial bids.

(c) The total marks obtained by a Bidder in technical bid shall be allocated 80% weightage and the financial bids shall be allocated 20% weightage and thereby making a total of 100% final weightage for the complete bid.

(d) The final evaluation will be done on the basis of Quality & Cost based selection system (QCBS) i.e 80% weightage for technical qualification and 20% weightage for financial parameters.
