Evaluation of Technical Bids for "Rehabilitation of Km 0.00 to Km 12.00 section in Andaman Trunk Road of NH-4 to Intermediate lane with hard shoulder in the Union Territory of Andaman & Nicobar Islands (Total Length 12.00 km) on EPC Mode (Package-V) (2nd Call)"-Empowered Technical Bid Evaluation Committee (ETEC) held on 01.02.2019 at NHIDCL, HQ.

The RFP for the subject work was invited with Bid Due Date as 24.01.2019 till 11:00 hrs. In all, 4 (four) bids were received from the following bidders:

2. The hard copy of the original documents along with the soft copy as received from e-procurement portal (CPPP) were handed over to the concerned Financial Consultant **M/s. Amit Ray & Co.** for carrying out the evaluation of the Technical Bids as per the RFP provisions. The Financial Consultant, vide their letter no. NHIDCL/18-19/014 dated 01.02.2019, has submitted their final report.

3. Committee deliberated in detail upon the report received and observed that all four (4) bidders i.e. M/s Amit Singla; M/s Dineshchandra R. Agrawal Infracon Pvt. Ltd.; M/s Jandu Construction Company and M/s Mohan Mutha Exports Pvt. Ltd. are fulfilling the RFP criteria of responsiveness. Committee was informed that 3 (three) bidders out of four have not submitted some documents provisioned in the RFP, however Technical Bid Evaluation has been carried out as such there was no major effect of these documents on the evaluation process and the outcome is as under.

According to Section 2.14.1.1 of RFP documents of MoRTH wherein it has been mentioned that ***“DSC should be in the name of the authorized signatory as authorized in Appendix III of this RFP or person executing/delegating such Appendix III in favour of Authorized Signatory”***. Since, Mr. Hansraj Mutha is one of the Directors of the company, Committee agreed with the same.
