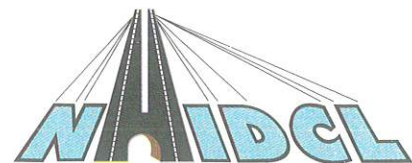



4. During the meeting, the case of M/s Shivalaya Construction Co. Pvt. Ltd. in JV with M/s KMC Construction Pvt. Ltd. was discussed with Legal Division of NHIDCL and it has been confirmed that M/s Shivalaya Construction Co. Pvt. Ltd. in JV with M/s Hindustan Construction Company Pvt. Ltd. has been placed in Negative list for 2 years vide Office Order no. NHIDCL/R-J/NH-07/2018/Pkg-II/795 dt. 17.03.2021 and M/s KMC Construction Pvt. Ltd. has been placed in Negative List for 1 year vide Office Order no. NHIDCL/Tripura/A-U/KMC/Payment/2016/563 dt. 07.07.2021. Further, Legal Division apprised that M/s Shivalaya Construction Co. Pvt. Ltd. is not allowed to bid in any of the tenders of NHIDCL, neither as sole nor in JV during the negative list period as per NHIDCL Policy.

5. After due deliberations, TEC agreed and recommended the opening of financial proposals of the following 6 (Six) applicant firms after obtaining approval of the Competent Authority:-


