Sir,

This has reference to your Technical and Financial proposals submitted on 21.08.2018 for the subject project and the subsequent contract negotiations held on 14.12.2018, 11.01.2019 & 01.02.2019 at NHIDCL Headquarters, New Delhi.

2. The Competent Authority has accepted your negotiated Financial Proposal for a **modified contract price of Rs. 15,20,80,200 (Fifteen Crore Twenty Lakh Eighty Thousand Two Hundred Only).**
3. The above financial quote is inclusive of all taxes, duties, fees, levies and other imposition imposed under the existing law and the client i.e. NHIDCL shall deduct taxes, as applicable, out of the payments to be made in favour of the Consultant.
4. The amount towards GST shall be paid by NHIDCL separately on reimbursement basis, after submission of proof of depositing the same with the concerned Authorities.

5. You are requested to submit an undertaking stating that none of your proposed key personnel and sub-professional staff has been blacklisted/debarred by the MoRTH and its implementing agencies. In case, it is found to be contrary at a later stage, you will have to replace them immediately without claiming any compensation for such staff.
6. You are required to confirm your acceptance of this 'LOA' within 07 days from the date of issue of this letter. As per condition of the contract Clause-13 of Terms of Reference (TOR), you are required to submit the Bank Guarantee (BG) within 10 days of issue of LOA from the bank towards the Performance Security of Rs. **Rs. 38,02,005/-** (Thirty Eight Lakh Two Thousand Five Only) (2.5% of the Contract Value) valid for a period as specified in the RFP. The Bank Guarantee (BG) shall be in the format in the Appendix-H (Bank Guarantee for Performance security) as given in the RFP.
7. Upon submission of the required Performance Security, you are required to sign the Contract Agreement with NHIDCL. Thereafter, the services shall commence immediately within one month from the date of signing of the Consultancy Agreement and accordingly you are required to mobilize the key personnel including Team Leader and other field staff as per the Contract Provisions.
8. Minutes of Contract Negotiation Meeting dated 01.02.2019 shall be the part of the Contract Agreement.
9. Kindly note that your firm will fully engage itself with the work and articulate the role of Associates partner and itself.
10. You are requested to sign and return the duplicate copy of the LOA in acknowledgement thereof, at the earliest.
