TERMS AND CONDITIONS

Name of work: Supply, Installation and Commissioning of silent/sound proof, Air cooled 5 KVA Diesel Generator Qty-01 of reputed brand (KOEL/Mahindra/ Cummins) for PMU-Ccpur, NHIDCL in the State of Manipur.

1. The eligibility for Bidder shall be a valid dealership of Diesel Generators, if it is a dealer, and valid GST No. if it is a supplier, firm/ agencies or an individual and having requisite experience of Supply, Installation, Testing and Commissioning of DG sets.
2. The item to be supplied should qualify the following minimum specifications:-
 - (a) The Diesel Generator (DG) must be silent/ sound proof below (75 dBA in operating condition) and must confirm to Central Pollution Control Board Guidelines (CPCB)
 - (b) The DG shall have onsite warranty for period of 2 years, and shall be inclusive of the provision of onsite servicing for a period of 1 Year.
 - (c) The DG should have the monitoring features such as lube oil pressure indicator, Engine temperature indicator, Run hours meter, Fuel Level indicator amongst others.
 - (d) It shall have a fuel tank of minimum capacity of 10 litres.
3. Supply and commissioning of Diesel Generators as per technical specifications including transportation loading/ unloading in the location.
4. Any other ancillary work, related to but not mentioned above, required for satisfactorily completion of the job.
5. Unless otherwise specified in the tender documents, any additional work shall be done by the contractor and therefore, their cost shall be deemed to be included in their tendered cost, whether specifically indicated in the schedule of work or not.
6. The Complete items are to be supplied within 10 days from the date of signing of contract
7. The Supply, Installation and commissioning shall have to be completed within 02 days from the date of supply of the items i.e all works required till successful commissioning must be completed within 02 days from the supply of item.
8. If the job is delayed beyond the specified time period, the PMU-Ccpur, shall at its discretion terminate the contract or impose suitable penalty/Liquidated Damages.
