- 8. The amendments/clarifications to the Bid Document if any shall be hosted on said websites.
- 9. The Bids shall be submitted online in the prescribed format given on the said websites on or before the date and time as mentioned above. **No other mode of submission is**

acceptable. The Technical Bid shall be opened online only and subsequently financial bid shall be opened online, only of those bidders whose technical bid is found responsive.

- 10. Representatives of the bidders (maximum upto two) who choose to attend may attend the online opening of the bids at Regional Office, Kohima on the date and time as mentioned above. However, such representatives shall be allowed to attend the opening of the bids only if they produce letter of authority on the letter head of the bidder, at the time of opening of bids as mentioned above.
