1. Following modifications in RFP/NIT as per MoRTH OM at Ref(i) above are as under:

No Financial proposal for the packages / projects is to be submitted separately. The most preferred bidder (H-1) for each package would be determined on the basis of 100% Quality (i. e. Highest technical scorer) as mentioned in RFP. Award of work consultant with "a Particular Team" either as sole or as in JV/Association shall be limited to one package only. Joint venture shall not have more than two firms.

the package which is to be awarded to the Consultant with "a particular team" shall be determined on the basis of maximum length of the package i. e. the package having the largest length will be given to that preferred bidder and in other, 2<sup>nd</sup> highest bidder will be most preferred bidder.

Further, in case the length of such packages is equal, (then the package at earlier serial number in Annexure-1 as mentioned in RFP will be given to that preferred bidder (H-1) and in other, 2<sup>nd</sup> highest bidder (H-2) will be given next serial number of packages having same length.)

No Financial proposal for the packages / projects are to be submitted separately. The most preferred bidder (H-1) for each package would be determined on the basis of 100% Quality (i. e. Highest technical scorer) as mentioned in RFP. Award of work consultant with "a Particular Team" either as sole or as in JV/Association shall be limited to one package only. Joint venture shall not have more than two firms.

For example:

(i) if a consultant in H-1 in Package- A has length of 120Km and also H-1 in Package-B having length of 100 Km, Consultant will be awarded Package-A on Account of Larger length i.e. highest quality.

(ii) if a consultant is H-1 in Package- 2 having length of 100 Km and he is also H-1 in Package-5 having length of 100 Km, then Consultant (H-1) will be awarded Package-2 on Account of earlier Serial number in Annex-1 as mentioned in RFP and 2<sup>nd</sup> higher bidder (H-2) will be given package-5 which is next Serial number in Annex-1 as mentioned in RFP having same length of 100 km.
