Minutes of Meeting of the Empowered Financial Evaluation Committee (EFEC), held at NHIDCL, New Delhi, on 06.03.2019, for Consultancy Services for Authority's Engineer for supervision of:

- (i) Up-gradation to 4-lane with Paved Shoulder of Jammu-Akhnoor road section of NH-144A from Canal head (Km 0.800) to Ganesh Vihar (Km 6.000) of 5.2 Km length
- (ii) Up-gradation to 4-lane with Paved Shoulder of Jammu-Akhnoor road section of NH-144A from Ganesh Vihar (Km 6.000) to Hanuman Chowk (Km 30.000) of 24 Km length in the state of Jammu and Kashmir to be executed on EPC basis.
- (iii) Widening and Up-gradation to 2 lane with paved shoulder configuration and geometric improvement from km 0.000 to km 16.990 on Chenani Sudhmahadev section of NH-244 in the state of Jammu and Kashmir to be executed on EPC basis

Opening of bids on e-Portal (Financial)- Empowered Finance Bid opening Committee (EFBC) opened the financial bid of the following technically eligible firm on 05.03.2019 at 1100 hrs online in the presence of representatives of the bidders (Annexure-I)

- 2. The Committee opened the Financial Proposals of technically responsive bidders. It was noted that while uploading the bid, a BOQ with amount *inclusive of all taxes* including GST was uploaded on the CPP Portal. Vide Amendment No 2 dated 28.10.2019, a Modified BoQ was uploaded where bidders were required to submit the financial proposal separately as an amount without GST and with GST. As the Old BOQ could not be withdrawn from the Portal, both the BOQs were available to the bidders.
- 3. The Committee noted that the relevant paras with respect to the bidder's Financial Bid are as below:

Clause 3.7 of Section-2 of RFP reads:

"The Financial Proposal should clearly identify as a separate amount, the local taxes (including social security), duties, fees, levies and other charges imposed under the applicable law, on the consultants, the sub-consultants, and their personnel (other than nationals or permanent residents of the government's country);unless the Data Sheet specifies otherwise. This cost, however, will not be considered in evaluation."

Clause 3.8 of Section-2 of RFP reads:

"Consultants may express the price of their services inclusive of all taxes including GST in the Indian Rupees only."

Clause 3.3 of Data Sheet, of RFP reads:

"Consultant has to assess all taxes including GST and should build them in their financial proposal. These taxes should not be provided separately. Consultants are requested to consult Tax Consultants for details."

4. EFEC checked the status of bidders considering both the prices i.e. price *inclusive of GSTs and exclusive of GST*. The details of Financial Proposals of the Technically Responsive
