TERMS AND CONDITIONS

Name of work: Supply, Installation and Commissioning of silent/sound proof, Air cooled 15 KVA Diesel Generator Qty-01 of reputed brand (KOEL/Mahindra/ Cummins) for PMU-Noney, NHIDCL in the State of Manipur.

1. The eligibility for Bidder shall be a valid dealership of Diesel Generators, if it is a dealer, and valid GST no if it is a supplier, firm/ agencies or an individual and having requisite experience of Supply, Installation, Testing and Commissioning of DG sets.
2. The item supplied should qualify the following minimum specifications:-
 - (a) Diesel Generator (DG) must be silent/ sound proof below 75 dBA in operating condition) and must confirm to Central Pollution Control Board Guidelines (CPCB)
 - (b) The DG should have 2 years onsite warranty.
 - (c) The DG should have the monitoring features such as lube oil pressure indicator, Engine temperature indicator, Run hours meter, Fuel Level indicator amongst others.
 - (d) It should have a fuel tank capacity of minimum 50 litres.
3. Supply and commissioning of Diesel Generators as per technical specifications including transportation loading/ unloading in the location and canopy for covering should also be provided.
4. Any other ancillary work, related to but not mentioned above, required for satisfactory completion of the job.
5. Unless otherwise specified in the tender documents, any additional work shall be done by the contractor and therefore, their cost shall be deemed to be included in their tendered cost, whether specifically indicated in the schedule of work or not.
6. Complete items to be supplied within 10 days from the date of signing of contract
7. Supply, Installation and commissioning to be completed within 02 days from the supply of items i.e all works required till successful commissioning must be completed within 02 days from the supply of item.
8. If the job is delayed beyond the given time period, PMU-Noney, shall at its discretion terminate the contract or impose suitable penalty/Liquidated Damage.
