Minutes of Meeting of Empowered Technical Bid Opening Committee (ETBC) on 23.06.2020 to open technical bids for the Consultancy services for Authority's Engineer for Supervision of "(i) Construction of two lane with hard shoulder of Kohima-Jessami Road on NH-29 (Old NH-150) From existing km 7.880 (near Chedama Junction) to existing km 30.474 (near Chakahabama) [Design Km 7.88 to design Km 29.6] [Design Length - 21.72 Km] in the state of Nagaland Under Bharatmala Pariyojana on EPC Mode (Package-I)

(ii) Construction of two lane with hard shoulder of Kohima-Jessami Road on NH-29 (Old NH-150) From existing km 30.474 (near Kidwema road Chakahabama) to existing km 53.220 (near Kikruma Village) [Design Km 29.6 to design Km 51.5] [Design Length - 21.90 Km] in the state of Nagaland under Bharatmala Pariyojna on EPC Mode (Package II)"

(iii) Construction of two lane with hard shoulder of Kohima-jessami Road on NH-29 (Old NH-150) from existing km 53.220 (near Kikruma Village) to existing km 76.320 (near Mesulumi Village) [Design Km 51.5 to design Km 74.2] [Design Length - 22.7 Km] in the state of Nagaland Under Bharatmala Pariyojana on EPC Mode (Package III)".

The bids for subject project were invited from the prospective bidders with bid due date on 22.06.2020 till 1100 Hrs.

2. Duly constituted Empowered Technical Bid Opening Committee (ETBC) met to open the Technical Bids on 23.06.2020 at 1100 Hours. No authorized representatives from the firms were present.

3. Member Secretary apprised the Committee that:

3.1 As per clause 19 of Section-1 (Information to Consultants) of RFP that "*The two parts of the Proposal (Technical proposal and Financial proposal) must be submitted on-line only with all pages numbered serially, along with an index of submission as per procedure under e-tendering. Physical submission of the proposal shall not be accepted. In the event, any of the instructions mentioned herein have not been adhered to, the Employer may reject the Proposal.*" Therefore, following firms were noted to have uploaded their bids by due date and time on the CPP Portal as well as on INFRACON portal:
