Minutes of Meeting of Financial Evaluation Committee (FEC) held on 04.08. 2020 to evaluate the financial bids for Consultancy Services for Authority's Engineer for Supervision of:

(i) Construction of two lane with hard shoulder of Kohima-Jessami Road on NH-29 (Old NH-150) From existing km 7.880 (near Chedama Junction) to existing km 30.474 (near Chakahabama) [Design Km 7.88 to design Km 29.6] [Design Length - 21.72 Km] in the state of Nagaland Under Bharatmala Pariyojana on EPC Mode (Package-I)

(ii) Construction of two lane with hard shoulder of Kohima-Jessami Road on NH-29 (Old NH-150) From existing km 30.474 (near Kidwema road Chakahabama) to existing km 53.220 (near Kikruma Village) [Design Km 29.6 to design Km 51.5] [Design Length - 21.90 Km] in the state of Nagaland under Bharatmala Pariyojana on EPC Mode (Package II)

(iii) Construction of two lane with hard shoulder of Kohima-Jessami Road on NH-29 (Old NH-150) from existing km 53.220 (near Kikruma Village) to existing km 76.320 (near Mesulumi Village) [Design Km 51.5 to design Km 74.2] [Design Length - 22.7 Km] in the state of Nagaland Under Bharatmala Pariyojana on EPC Mode (Package III)

ETBC had opened the Technical bids on 23.06.2020. Empowered Technical Bid Evaluation Committee (ETEC) met on 16.07.2020 to evaluate the proposals as per the terms of RFP document. After Evaluation of Technical Proposals by ETEC, 03 (Three) firms were found eligible for opening of Financial Proposal with Technical Score as under:

5 Clause 23 regarding the Participation of Consultant in bidding process of NHIDCL states that

The bidder either as individual firm or in JV or in association, who are having (three) or more on – going Authority’s Engineer Consultancy Contract(s) in NHIDCL, as on date of bid submission, shall not be eligible to bid for this Authority’s Engineer Consultancy Contract (Issuance of LOA will be considered as an on-going Authority’s Engineer Consultancy contracts).

AND

The bidder shall not be awarded more than 3 (three) Authority’s Engineer Consultancy Contracts for current bidding process in NHIDCL

6 Since as per clause 23 of the RFP, any bidder either as individual firm or in JV or in association cannot be awarded more than 3 projects, the financial bid of M/s Marc Technocrats Private Limited- M/s G Eng Advisory Services Private Limited (JV) should not have been opened. Therefore, the committee recommends re-inviting the bid for the subject consultancy work subsequent to the approval of the competent authority.
