2. The Empowered Technical Bid Opening Committee (ETBC) opened 2 nos. technical bids in its meeting held on 27.12.2019.


3. The evaluation of the firm were carried out based on the details submitted on INFRACON by both the firms. The additional data which was required was taken from bids submitted on CPPP Portal. The First Stage Evaluation carried out for both the bidders viz. M/s C M Engineering & Solution and M/s Casta Engineers Pvt. Ltd in association with KQC Global Consultants PVT. LTD with the eligibility status is as under with details mentioned in the First Stage Evaluation Report enclosed at **Annexure- I.**

As per clause 5.1 of RFP which is reproduced herein “ In case answers to any of the items from sl no (i) to sl no (vii) is “NO”, the bid shall be declared as non-responsive and shall not be evaluated further. A consultant satisfying the minimum eligibility criteria as mentioned in the Data sheet and who had submitted the documents from sl no(i) to sl no(vii) of RFP clause 5.1 shall be declared “Pass” in proof of eligibility and the Technical Proposals of only those consultants shall be opened and evaluated further.”

5. It is submitted that CM Engineering & Solution has failed as per clause 5.1 of RFP sl no (iii). Details of First stage evaluation is enclosed as Annexure-I.

6. In light of all above, as only One bidder is qualifying , hence it is recommended to annul the bidding process.
