Minutes of Meeting of Empowered Technical Evaluation Committee (ETEC) on 15.11.2018 for "Consultancy Services for Feasibility Study, Preparation of Detailed Project Report and providing pre-construction services for Construction of 2-Lane Bridge for Connectivity of Port Blair-Chatham Island and Bambooflat with 200mtr to 400mtr Navigational span in the Union Territory region of Andaman Nicobar Islands" held at NHIDCL, New Delhi.

Having carried out the technical evaluation, the ETEC decided to seek the comments from all the bidders on Technical Evaluation results for any necessary correction required in the communicated technical result vide ETEC Minutes dated 13.11.2018. Only 1 (one) bidder i.e. M/s VKS Infratech Management Pvt. Ltd. vide their letter no. VKSIMPL/BD/NHIDCL/001 dated 14.11.2018 furnished their comment in response.

2. The ETEC examined the comment of the above mentioned bidder. It was found that the inadvertently weightage of Span (440m single span) in one of the claimed project i.e. *Single Span Dobra Chanti Suspension Bridge* has been taken 40% for other lead partner (i.e. 176mtr) instead of 50%. Hence, the modified length of Single span is 220m (50% weightage) for evaluation and the said project falls within span length criteria of 200m to 250m, resulting in change in technical score of 11 Marks instead of 4 Marks. The modified technical score after consideration of the representations stands as under:
