As per Annexure-IV, the bidder has erroneously submitted 8 projects of Rs 475.69 Cr for claiming technical experience under clause 2.2.2.2 (i), which actually adds to Rs 438.95 Cr. The technical experience of these 8 projects is evaluated to be Rs 447.72 Cr as per Annexure-IV against the

				requirement of Rs 452.65 Cr. Accordingly, the bidder M/s Pappu Prasad is non-responsive as per Clause 2.2.2.2 (i) of RFP. SFMS Confirmation not yet received.
(vi)	M/s ASC Infratech Private Limited	Technically Non-Responsive	Not Eligible	M/s ASC Infratech Private Limited, only two projects i.e. project code "K" & "L" are eligible for claiming similar work experience under clause 2.2.2.2 (ii) of RFP. However, total payment received upto 31.03.2023 in respect of project code "K" is Rs. 67.77 Crore against the contract value of Rs. 98.22 Cr which is 69% of the contract value. Similarly, in respect of project code "L" total payment received upto 31.03.2023 is Rs. 63.90 Cr against the contract value of Rs. 101.00 cr. Which is 63.26% of the contract value. Hence, the bidder, M/s ASC Infratech Private Limited fails to meet the requirement of similar work experience under clause 2.2.2.2 (ii) of RFP. Thus, the bidder, M/s ASC Infratech Private Limited is non-responsive under clause 2.2.2.2 (ii) of RFP. SFMS Confirmation to be obtained.
