- 3. The Empowered Financial Evaluation Committee (EFEC) discussed in detail the financial bids of the technically responsive bidders and observed as under:
  - i. The bid price Rs. 86,47,000,00/- (Rupees Eighty six crore forty seven lakh only) quoted by M/s Shiva Buildtech Pvt Ltd. (which is 7.01% below) than the estimated cost of Rs 92.99 crore is the lowest quote among all the bidders. Therefore, the same is the lowest bidder as per clause 1.2.6 of the RFP and is recommended as selected bidder as per clause 3.3.1 of the RFP.
  - ii. The Committee further observed that the bid price of the selected bidder i.e M/s Shiva Buildtech Pvt Ltd is lower by less than 10% with respect to the estimated project cost (i.e Rs. 92.99 Cr.). The bidder shall furnish only performance security of 5% as per clause 2.21.1 of the RFP.

Committee, after deliberation, recommended to award the work to selected bidder i.e M/s Shiva Buildtech Pvt Ltd at the quoted price of 86,47,000,00/- (Rupees Eighty six crore forty seven lakh only) with performance Bank Guarantee of Rs. 4,32,35,000/- (Rupees Four Crore thirty two lakh thirty five thousand only) after approval of Competent Authority
