

National Highways & Infrastructure Development Corporation Ltd

Meeting of Empowered Technical Bid Evaluation Committee (ETEC) held on 11.12.2017 at NHIDCL HQ, New Delhi, for Short Tender for “Specialised Consultancy Services for ‘Good for Tender’ design based on detailed investigations, estimation, survey, costing, preparation of Detailed Project Report, Technical Schedules of EPC documents and Land Acquisition Survey and Pre-Construction activities for Construction of 4 nos. of bypasses at Chhiathlang, Serchhip, Hnathial and Lawngtlai on Aizawl-Tuipang section of NH-54 in the state of Mizoram”.

Having opened the technical Bids on 08.12.2017 at 1730 hrs, the technical proposals of the following firms, who had submitted their bids by due date and time, were handed over to the Empowered Technical Bid Opening Committee (ETBC) to evaluate and assess the general responsiveness of the bids:

- (i) M/s Shyam Designer and Consultants Pvt. Ltd.
- (ii) M/s Pentacle Consultants (India) Private Limited
- (iii) M/s PNG Planning & Structural Consultants Pvt. Ltd.

2. The Committee found that all the bids are broadly responsive according to provisions of the RFP. The committee therefore recommends that the bids of all three bidders be technically evaluated to adjudge the technical responsiveness of bids.

3. ETEC noted that one of bidder M/s PNG Planning & Structural Consultants Pvt. Ltd. has submitted bid security in the form of Call Deposit Receipt (CDR) in favour of MD, NHIDCL (instead of Bank Guarantee or DD required as per RFP). Committee was of the opinion that the same may be accepted subject to the approval of the Competent Authority.

4. Committee also noted that Power to the signatory of bidding document for M/s Shyam Designer and Consultants Pvt. Ltd. & M/s PNG Planning & Structural Consultants Pvt. Ltd were delegated through Board Resolution attached with the Proposal. The online document of these firms was also uploaded by the same person. Power to signatory, Mr. Chetan Pathare of M/s Pentacle Consultants (India) Pvt. Ltd. has been delegated by Mr. Mahendra P. More, CEO of the company who (the CEO) has uploaded the online document. The Committee was of the opinion that the same may be considered.

5. Committee recommended that the financial bids of following eligible bidders may be opened subject to approval of the Competent Authority considering the facts as per para 3 & 4 above.
