Competent Authority hereby accepts your bid for the quoted amount of **Rs.135,99,00,000/- (Rupees One Hundred Thirty Five Crores Ninety Nine Lakhs only)**as included in Performa for quoting the rates (i.e Electronic Bid) for the above work and declares you as **“Selected Bidder”** in accordance with the clause 3.3.1 of RFP. Please note that the amount of Bid Price payable to you by Authority shall be in accordance with the provisions of RFP documents. The Construction period is 36 months from the “Appointed date”

2. In accordance with clause 3.3.4 of the RFP document, it is requested to return the signed copy of the duplicate letter of acceptance (LOA) with your acknowledgment within 7(Seven) days of receipt of LOA. Thereafter, you are required to execute contract Agreement in accordance with clause 3.3.5 within 15 (Fifteen) days from the date of issue of LOA as per Clause 1.3 of RFP.

3. Further, as per RFP documents, the contractor for due and faithful performance of its obligations during the Construction period as well as Defects Liability Period, shall furnish a

Performance Security by way of an irrevocable and Unconditional Bank Guarantee in accordance with clause 7.1.1 of Article 7 of Contract Agreement within 10 days from signing of the Contract Agreement. As per the Article 7 of the DCA, you have to furnish a Performance Security of 5% of the amount quoted by you amounting to **Rs. 6,79,95,000/- (Rupees Six Crore Seventy Nine Lakh Ninety Five Thousand Only)** and Additional Performance Security of **Rs. 2,29,32,000/- (Rupees Two Crore Twenty Nine Lakh Thirty Two Thousand Only)**. The Performance Security shall be valid until 60(Sixty) days after the Defect Liability Period, whereas the Additional Performance Security shall be valid until 28 (twenty eight) days after the issue of Completion Certificate under Article 12 of the DCA.
